## A NEW BALANCE OF POWER IN EUROPE? How the European elections will shape Italy and the EU

ROME, 3 JULY 2024 10.00-13.00

The elections for the European Parliament have redefined the political landscape in the EU. The traditional majority of pro-European political forces has been confirmed, even if with weakened proportions, and Ursula Von der Leyen will now seek a second term. However, hard right parties have gained ground in key EU member states like France, Germany and Italy, challenging the established balance of power within the EU. The vote has taken place at the conclusion of a 5years institutional cycle characterized by structural shocks such as the pandemic and the Russian aggression against Ukraine. The EU has been able to respond with innovative solutions to the new challenges and the European Commission led Von der Leyen has become a more politicized institution, almost a household name for many European citizens, making the questions on a new majority in the European Parliament even more pressing than in the past. However, the vote in June has been once again mainly driven by domestic affairs. In several countries, including Italy, the European elections have been framed as a check on the parties' electoral strength. Key European issues like the Green Deal or the military assistance to Ukraine have been usually linked to national political dynamics. In Italy, in particular, the electoral campaign has been dominated by the political parties' attempt to assess their position, either in government or in opposition, in what was primarily interpreted as a mid-term election.

Against this background, the workshop will discuss the outcome of the vote and key trends in the electoral campaign that preceded it, exploring their implications at the national and the European level. In the first session, experts and researchers will look into the electoral campaign in Italy and the results of the vote, especially when it comes to the role of Italy in the future institutional structure of the EU. In the second session, the elections will be analysed through a comparative lens, broadening the scope of the discussion to other key EU member states like France, Germany, Poland and the Netherlands.
